## Dog Daycare Responsibilities & Requirements

The purpose of Paw-Zn-Around Dog Daycare Center is to provide a safe, fun and stimulating social environment for dogs during their visit. We have more than 23 years of combined experience in dog care, training and behavior - we pride ourselves in providing loving and high quality care. To ensure the safety and health of your pet, our other guests, and valued staff, we require all guests to comply with the following rules and requirements. **Our Hours of Operation are 6:30 am - 5:30 pm M-F**

\_\_\_\_\_ All dogs must be spayed or neutered by 6 months of age. (Documentation from your veterinarian is required)

\_\_\_\_\_ Puppies at least 12 weeks of age may attend provided they have completed their second set of shots; third set must be completed within 4 weeks.

\_\_\_\_\_ **Prior to admittance for evaluation, your dog must meet the following health requirements.** Photocopies of veterinarian records, including expiration dates must be provided. Dogs whose inoculations/tests are not current cannot be evaluated or attend daycare. It is the owner's responsibility to keep inoculation/tests up to date and provide documentation to Paw-Zn-Around.

- Rabies - **The Rabies certificate or veterinarian proof of vaccine** (not tags) must be provided, and tag attached to collar. Follow-up boosters are required at least every three years or as advised by your veterinarian.
- DHLPP/DHPP - Distemper, Hepatitis, Leptospirosis, Parainfluenza, Paravovirus vaccinations must be current and kept up-to-date. Leptospirosis is option and at the discretion of your veterinarian but, you should advise your veterinarian that your dog spends time at a doggy daycare in a rural setting. **Titers are accepted.**
- Bordatella (Kennel Cough) - This immunization is generally given by your veterinarian only upon request and should be repeated every six months for dogs who attend daycare. If your dog has never had this immunization or it has expired, **it must be administered 2 or more days before evaluation.** It may be given as an injection or intranasal at the discretion of your veterinarian.
- Fecal Test - All dogs must have a fecal flotation (feces sample) test by your veterinarian to check for parasites and bacterial infection. **The test must be done no more than 14 days prior the evaluation. The veterinarian record must show the fecal test was "clean" or "negative".** If any parasites or infections are found in the feces, your dog cannot have an evaluation or attend daycare until treatment is completed and a new test is conducted showing the results are "negative." We require a minimum of one Fecal test each year, with a **copy of the TEST RESULTS** provided to us on an annual basis.

\_\_\_\_\_ Owners must provide timely **up-to-date** vaccination records, annual fecal testing results, and report **any changes** in health, behavior, diet, vet, etc **in writing**.

\_\_\_\_\_ All Dogs must be in good health. **By signing in, Owners certify their dogs are in good health and have not been ill for the last 3 days.** Upon admission all dogs must be free of any condition which could potentially jeopardize other guests. Dogs that have been ill with a communicable condition in the last 14 days will require a veterinarian certification of health in order to be admitted or readmitted to daycare and/or boarding. Dogs with stitches or open wounds should NOT attend Daycare.

\_\_\_\_\_ All dogs' behavior must be **nonaggressive** and not toy protective, and must not be aggressive towards people or other dogs. Any and all aggressive type behaviors must be disclosed to ensure the safety of all dogs and staff.

\_\_\_\_\_ All dogs must have a completed, signed and approved application on file and provide timely updated information as needed in writing.

\_\_\_\_\_ Owners understand that **payment for services is due upon delivery** of said pet and will follow guidelines for drop-off and pick-up times and processes, including the use of leashes (***No retractables***) when coming and going. **We ask that all dogs arrive by 9:00am.**

\_\_\_\_\_ Owners understand that they are responsible for providing adequate food treats & snacks.

\_\_\_\_\_ A late fee of \$10 may be assessed for any dog picked up after 5:40pm. Any dog still here after 6:00pm will automatically be boarded for the evening at an additional charge of \$7. Any dog not picked up on Friday evening will incur a \$100 fee in addition to pet sitting fees for the weekend.

A Maine dog license for the current year is a state law for all dogs age three months and older. When Rabies shots are given, your veterinarian is required by law to forward a copy of your rabies certificate to the State, who in turn, advises the community you reside in.

Paw-Zn-Around management is committed to exercise due and reasonable care and to keep our daycare premises safe, sanitary and property enclosed. The pet is to be fed properly and regularly, exercised and to be housed in clean, safe quarters.

\_\_\_\_\_ All pets are boarded, or otherwise cared for by the Management and/or qualified staff without personal liability for loss or damage from disease, death, running away, theft, fire, injury to persons, other pets or property of said pet, or

other unavoidable causes; **due diligence and care having been exercised.**

\_\_\_\_\_Pet owners will be responsible for any medical expenses of their own pet and or any expenses due to their own pet injuring another pet. Owners are responsible damages due to their own pet destroying significant facility equipment such as crates.

\_\_\_\_\_Pet owners are responsible to provide food and treats for their dog. In the event food is not provided, Paw-Zn-Around will provide a quality dry food and/or treats at the owner's expense. Pet owners are NOT to give treats to other dogs without the Pet's owners permission.

\_\_\_\_\_If a pet is found to have fleas and/or ticks, it will be bathed at the owner's expense.

The pet is not to be taken off the premises except by the consent (verbal or written) of the owner.

\_\_\_\_\_If the pet is injured or becomes seriously ill, the owner shall be notified at once and/or the pets' veterinarian. If the owner does not inform immediately regarding measures to be taken, or if the state of the pet's health reasonably demands quick action, Management shall have the right to call a veterinarian, as designated by the owner (Pets file), or if no veterinarian is designated, to call a veterinarian of Paw-Zn-Around's choice or to take the pet to said veterinarian in either case; or administer medicine or give other advisable attention, within Management's discretion and judgment, and such expenses shall be paid promptly by the owner of the pet.

We are committed to the health and well being of each dog and partner with owners to make each day a great experience full of balanced fun, exercise and affection! Your commitment to comply with the above stated responsibilities and requirements help maximize our success in achieving our goals.
